## **OLD BUSINESS**

Councilman Roger Murray has gotten 2 quotes for an incentive from National Grid for a lighting upgrade for the town hall, highway garage, and salt barn. We would pay up front, and then get a rebate from National Grid.

Supervisor Latimer stated that spending the money now could leave us in a bind. He suggested possibly doing just the highway garage and salt barn now and the town hall next year. Councilman Murray stated that they could not do the salt barn now anyway because it has sand in it now. It was agreed that we would just do the town barn now. Councilman Murray said that he will check into it.

Danny Collins stood and said that he was representing the St. Lawrence County ATV trail committee. They would like to know if the town would allow them to use the highway garage parking lot as a loading area, since they are opening up a portion of County Route 24. Supervisor Latimer stated that yes, the town board is in favor of letting them use the highway garage parking lot for loading and unloading ATVs.

Resident Bill Mein asked if it would be possible to list the correspondence on the agenda. Town Attorney Charles Nash suggested that an extra folder with correspondence be prepared for the public to view prior to meetings. The board agreed that this could be done.
