Supervisor Powers called the meeting to order at 7:00 PM and Councilman Dahl McCormick led us in the Pledge of Allegiance.

Motion by Roger Murray, seconded by John Glasgow, to accept the minutes of the July 27, 2021 Regular Meeting as submitted, all in favor.

Motion by Dahl McCormick, seconded by Roger Murray, to accept the Supervisor's Report for the month of July 2021 as submitted, all in favor. (Along with the Supervisor's Report are the Annual Update Document for 2020 that we submitted to New York State and the mileage report from the highway department).

Motion by John Glasgow, seconded by Dan Huntley, to accept the Town Clerk's Report for July 2021 as submitted, all in favor. (Total local shares remitted: \$583.28, \$27.00 to NYS Ag & Markets, \$4.72 to NYS Environmental Conservation).

Motion by John Glasgow, seconded by Dahl McCormick, to accept the Code Enforcement Report for Permits #27-21 through #31-21 as submitted, Total \$135.00, all in favor. Code Enforcement Officer Darren Richards stated that the printer in his office

does not work. He would like to request a printer/scanner to share with the assessor.

Also, he would like to request magnetic signs for his vehicle while he is visiting sites and doing inspections. He reports that we have 3 new homes going up in the town.

Motion by Roger Murray, seconded by Dan Huntley, all in favor, to allow Code Enforcement Officer Darren Richards to choose a printer/scanner for his office and to allow Supervisor Powers to authorize the purchase.

St. Lawrence County Legislator's Report:

St. Lawrence County Legislator Rick Perkins reported that County Full Board meeting was held on August 2nd at the Gouverneur Fair. They had 38 resolutions, including 9 modifications to the budget, 21 agreements/contracts, 9 vacancies filled, reversing the default of the Norwood Bakery, Proclaiming August as National Immunization Awareness Month. They also adopted a policy for the appropriate use of the St. Lawrence County Multi-Use Trail System, authorizing the use of the county work force and equipment and the creation of a reserve for the maintenance of the trails, etc. There was discussion about the investigation of shipwrecks near the Robert Moses dam (tabled). There was also discussion about invasive species on Black Lake. The census report is out and the county is down 3.17% from 2010. The Town of Pierrepont is down 63 people from 2010, with 2,523 people now. The County Tax Auction is online this year from September 11th to September 25th.

NEW BUSINESS

We have an Article 7 petition from Erie Boulevard Hydropower. She spoke to the Town of Colton supervisor and they have retained Lewis & Greer to handle it for them. So she has contacted them and they have agreed to represent us, pending approval of the retainer agreement. Our attorney, Colin Loomis, has reviewed and recommends approving it. They will charge \$195 per hour, (plus costs and disbursements).

Motion by Roger Murray, seconded by Dan Huntley, all in favor, to approve the retainer agreement with Lewis & Greer, P.C., Attorneys and Counselors-at-Law.

Motion by Dahl McCormick, seconded by Roger Murray, all in favor, to adopt Resolution #VII-2021: Regarding a Financial Matter Undertaken by the Governing Board in Regards to the Pierreport Town Justice Account. (see attached).

The computer that is being used for accounting needs to be updated.

Motion by Dahl McCormick, seconded by Roger Murray, all in favor, to approve the purchase of a new computer and/or printer for administrative assistant Laurie Hance.

We need to begin work on the 2022 budget. We will be scheduling a special work session soon to start the process.

Supervisor Powers stated that we have received a letter from the Daughters of the American Revolution regarding Constitution Week, which is September 17th through September 23rd. This year marks the 234rd anniversary of the adoption of the Constitution of the United States of America. The Town of Pierrepont Town Board wishes to recognize the importance of our constitution with the adoption of the following resolution:

OLD BUSINESS

<u>Planning Board Update:</u> Planning Board Chairman Pete Pomainville stated that the town board members have copies of the final draft of the solar law that the planning board has submitted. He said that the county has approved it and he wonders where we go from here.

Town attorney Colin Loomis stated that he needs time to read through it and then we will begin the process of enacting the local law and doing the long form SEQR.

Supervisor Powers stated that hopefully, we will have the public hearing for the local law at our October regular meeting.

Councilman Murray stated that he would like to thank our planning board for all the hard work they have done on this law.

We also need to decide if we need to extend the wind moratorium for 6 months. It was decided that we do need to. Our attorney will work on this.

We received a letter from New York State Division of the Budget regarding the ARPA Coronavirus Local Fiscal Recovery Fund. We will be receiving another \$1,035.93 because of some municipalities who were non-responsive.

<u>Painting of Historical Markers:</u> Town Clerk Melanie Thomas stated that she contacted Phil Jones and he responded that he would not be able to do it because of other obligations. We also tried Alexander Kovacs, who painted our stairwell and he is also not available. Councilman Murray said that he saw some historical signs in Potsdam that were freshly painted and maybe we could contact them to see who painted them.

We have a proposal from Northern Tier Contracting for \$5,484.00 to inspect and repair a 10 foot by 12 foot area on one wall of the town hall.

Motion by John Glasgow, seconded by Dan Huntley, all in favor to approve the proposal from Northern Tier Contracting.

We have some General Fund Transfers to be made.

Audits of the Town Justice account are audited by assigned Council members of the Town of Pierrepont. Council members are assigned this task by the Town Supervisor.

Audits of said Town Justice accounts are done on a monthly basis by use of cash receipts registers, Town Justice reports and records, etc. Total cash receipts and statements are verified by Council members.

For calendar year of 2020, records of the Town Justice accounts have been audited for the period of January 2020 - December 31, 2020.
