## **NEW BUSINESS**

Supervisor Powers stated that she would like to discuss the Cold War Veterans Exemption. The exemption had a 10 year limit, but now towns can adopt it to be permanent. We do not have the exemption, but we can adopt it. We have until December 1<sup>st</sup> to do it. At this time, we have 8 cold war veterans that are getting the exemption for county purposes. We will have to investigate to see how it will affect our taxpayers.

Highway Superintendent Shawn Spellacy stated that the highway department needs a



loader. He would like to trade the 2006 loader towards a new one. He said they would allow us \$52,500 for the old one and with the \$16,500 discount, it would cost us \$108,788. Supervisor Powers stated that she will think about it and then we will discuss it.

At our organizational meeting, we discussed that we need a new ZBA member to replace Phil Wagner. Peter Wyckoff is our alternate member. She said that she asked if he would be interested in being a regular member. He says that yes, he is interested in that.

**Motion** by Roger Murray, seconded by Dan Huntley, all in favor, to appoint Peter Wyckoff as a regular member of the Zoning Board of Appeals to replace Phil Wagner, term expiring on 12/31/18.

We now need to advertise for an alternate ZBA member and also another Board of Assessment Review member.

## **OLD BUSINESS**

We have Deb Christy, St. Lawrence County Trails Coordinator, here to discuss the trail system. In 2006, they opened a 50-mile pilot trail in Parishville. They continued opening another 66 miles, with a total of 116 miles open. It has all been operating well with no issues so far. Only 8 tickets were given last year, none for speeding or trespassing. This year, their goal is to connect from Pierrepont to Pitcairn and Harrisville, helping the towns through businesses and possibly the sale of property. She has brought a list of the roads in the town of Pierrepont that they would like to open, 11.3 miles, if we would agree to work with them. It would start at Brown's Bridge Road, go through private property of 6 owners, to State Highway 56 to Butternut Ridge Road, to Hadley Road, to the ATV Riding Area, to Church Road, to Post Road, to Streeter Road, to Howardville Road, to Coon Road, to Plains Road, to Allen Road, into Russell from there.

She is hoping we will pass a local law next month opening these trails. She has e-mailed us a draft of the local law that we can use.

She said this would be a multi-use trail for ATVs and horses mainly, no snowmobiles. ATVs are considered a motor vehicle so they can ride in the road just like a car.

Councilman Murray asked who is responsible for putting up signs? Ms. Christy stated that the county would be responsible for putting up signs.

Supervisor Powers stated that we should send this local law draft to our attorney, Eric Gustafson, so he can draw up the law for us and then we will have a public hearing.

Councilman Murray stated that he had spoken to St. Lawrence County Legislator Rick Perkins. Mr. Perkins could not make it here tonight because he had surgery yesterday. But he told him that the county is working on the pistol permit issue, the wind tower issue, and a by-pass around Canton and Potsdam.

Councilman Murray asked Town Tax Collector Melanie Thomas how many people took advantage of paying their Town/County taxes early (before Jan. 1<sup>st</sup>) this year. She said that about 60 people paid their taxes early (30 in person and 30 by mail).
